


How to settle taxes without leaving home?

3. Choose one of the options to log in to your tax profile:

- Log in using EPUAP, select -> **Login.gov.pl**
- If you don't have EPUAP, select -> **Your tax data** **Attention!** When choosing this option, you need to have a PESEL or NIP number and know the income amount for 2022 and 2023.

At this step, there is an option to change the language.



8. Please check all the information, including:

- Income
- Deductions and relief: Child relief and Social security contributions
- Paid tax
- Settlement method
- Your bank account
- Your details
- Tax office
- Other information

Each of these pieces of information can be edited if incorrect.

9. After conducting all the above analyses, review the declaration once again and check if the amount appears as:

Amount to pay -> This means that you need to pay the due amount (this may be the case if no tax advances were paid during a certain period).

Overpayment amount -> This means that such an amount will be refunded to your bank account.

Remember to check your account for this purpose!
